Reports President Noteworthy events included the Fete in May and the improvement to the entrance to the school, general landscaping, the installation of the bell, new flag poles and staff car parking. Publicity Some major publicity for the school included an entry in the 100 year celebration of the Coffs Harbour Advocate; two articles in the P&C Journal; and a school photo featured on the cover of the P&C Annual Report.

Canteen Deborah reported that a sink in profits in the first 6 months of 2007 alerted her to profit margins. Prices were increased and reasonable profits resumed for the second half of the year.
